The **Certified Port Educator**, organized by the Instituto dos Vinhos do Douro e do Porto, is aimed at <u>educating</u> <u>those who want to widen their global knowledge of Port and develop communicational skills in order to teach about Port</u>. Wine educators from the industry, who want to acquire more knowledge about this Designation of Origin, within the scope the study subject matter, allowing them to apply that knowledge in their professional capacity, are eligible and may apply.

Application Information (in English):

- Curriculum Vitae.
 - Note: Concrete information regarding educational activities and courses taught
- Motivational Letter (max. 2500 characters)
- Port-related video, maximum 1 minute long (mpeg format), on a theme chosen by the candidate for communication evaluation purposes.
 - NOTE: These three files must be sent via a link (wetransfer.com or other data storage resource). It is advised that you confirm the files were send (e-mail to cpe@ivdp.pt).

Requirements:

Fluency in English (the language in which the course is to be held)

Admission Criteria and participant selection:

- Each course limited to a maximum of <u>nine (9)</u> attendees.
- Geographical scope (based on importantly strategic markets for Port)
- Teaching experience and prospects of undertaking teaching activities on Port (of special relevance)
- Curricular evaluation (relevance given to teaching experience in the realm of Wine)
- Communication skills

Course Evaluation:

- Written test (multiple choice and 1 essay question)
- Practical test with wine tasting
- Oral presentation
- Written essay (minimum of 15 000 characters, maximum 25 000 characters), to be sent no later than 10 working days after the conclusion of the course. Please note that no exceptions will be made.

The written essay will be judged for its <u>originality</u> and <u>relevance</u> and must be related to Port.

The best essays may be published later, on the IVDP's dedicated online webpage.

Criteria:

- >= 70% in the evaluation tests: Certificate of participation.
- >= 70% in the evaluation tests and pass in written essay: Title of CPE.

Custo:

200 € + IVA (23%) - Includes *transfers* Porto | Gaia | Douro Region and lunch during the course. Payment to be made upon receiving confirmation of admission to the course.
