Guidelines for submitting papers

Paper submissions must be uploaded on-line via abstract submission platform of the Congress (<http://www.oiv.int/congres/OIV2014ARG/login>). First you should register and create your account, by following the instructions. Your personal user and password will enable you to log in and submit your paper, as well as to access the platform anytime afterwards.

Submissions must be received before **13th June 2014**.

A. Authors are required to:

1. **Select the form of presentation.** Three types of presentation are possible:
 - **Oral communication** (15 minutes).
 - **Brief communication** (5 minutes, 3 slides presentation).
 - **Poster**.

2. **Select a theme and a sub-theme** under which the abstract should be reviewed by the *Joint Reading and Selection Committee*. The *Joint Reading and Selection Committee* reserves the right to change the section and the sub-theme previously chosen by the author.

The abstracts will be evaluated according to their:

- relevance to the Congress theme, sections and sub-themes;
- scientific merit;
- importance to the Congress audience.

The *Joint Reading and Selection Committee* will specify the modality of the presentation (see above). If the oral presentation option is not selected, the paper still can be presented as a poster or a brief communication.

B. Submissions must contain:

- A title that describes the work, ideally about 10–12 words long.
- A list of contributing authors (names and affiliations), starting by the name of the main author. If there is more than one author, the name of the speaker should be underlined. It is noted here that the registration of the speaker is mandatory.
- The contact details of the contact author: name, mailing address, email, phone or fax number.
- The theme and the sub-theme in which the authors would like to integrate the paper and a list of 2 to 7 keywords.
- An abstract in three of the five official languages of the Congress (German, Spanish, French, English and Italian). One of the 3 versions should preferably be written in English. The abstract should not exceed 1,500 characters (with spaces) per language used. The objectives, methodology used as well as the new results and conclusions should be specified.

The decisions of the *Joint Reading and Selection Committee* will be communicated to the authors. The rules concerning the presentation of the final accepted papers (oral communication, short communication or poster) will be notified as well.

Final paper must be submitted online via the abstract submission platform of the Congress, through your account, by the indicated deadline on: <http://www.oiv.int/congres/OIV2014ARG/login>.

C. Important dates

- Deadline for submissions: **13th June 2014**.
- Notification of the decisions of the *Joint Reading and Selection Committee*: **7th July 2014**.
- Deadline for sending the final version of the papers: **15th September 2014**.

Important - new publication and indexation policy for Congress proceedings

The World Congress of Vine and Wine proceedings will be published and disseminated on a dedicated website on the [Web of Conferences](#) platform.

All the articles published will have a **stable internet identity**, which facilitates and provides for consistent identification and citation.

More specifically, each article will be:

- **given a DOI (Digital Object Identifier)**, which enables the permanent identification of the document on the web, facilitates the use of bibliographic databases and produces more reliable and sustainable citations,
- **indexed in the [CrossRef](#), [DOI Foundation](#) and [Google Scholar](#) databases, as well as in the [Conference Proceedings Citation Index](#),**
- **free to consult and download**, and published under the **Creative Commons Attribution licence**, which authorises the free use, distribution and reproduction of the work, provided the original document is properly referenced.

A range of services and indicators will be made available to authors and readers to encourage the circulation of scientific information and evaluate the impact thereof: search engines, alert systems, link-sharing, viewing statistics, follow-up of citations, etc. The site dedicated to the Congress will also offer a certain number of bibliometric tools.

In addition to publication on the site for the Congress and all the above mentioned services, we are offering authors submitting their article in English the chance to publish their work in the [BIO Web of Conferences](#) journal. This is an open access journal dedicated to the publishing of conference proceedings in the life sciences fields. Publication in this journal provides the opportunity to be indexed in the above databases, in addition to the [DOAJ](#) and [ProQuest](#).

Authors should give [EDP Sciences](#) a [license to publish the article](#) and identify EDP Sciences as the original publisher.

If the author does not want an electronic reference for their article because the work has already been published in another scientific journal, the text will be included in the compilation of communications distributed during the Congress.
