Proposal for Papers

The procedure for presenting proposals for papers is as follows:

Step 1:

Presentations summaries of paper proposals in three of the five official languages of the OIV (English, French, German, Italian and Spanish) by or before the deadline 22nd February, 2012.

Proposals for presentations (oral or poster) are to be submitted/uploaded on the Web page: www.oiv2012.org.tr

Presentations (oral or poster) must be original contributions.

Step 2:

The « Joint Reading and Selection Committee » which consists of official representatives of the OIV and of the members of the scientific committee will select paper proposals in March 2012. All presentations will be assessed within their sections and according to their topic.

The Joint Reading and Selection Committee's decision will specify the modality of the presentation (oral or poster) and exact placement of presentations within the programme of the Congress.

The presentations (oral and poster) will be assessed by the mentioned Committee on March 2012.

Step 3:

The decision by the Joint Reading and Selection Committee will be communicated to each author by March 2012.

Step 4:

Detailed information on conditions for presenting the final version of the paper (oral or poster) and their submission will be communicated to selected authors.

The deadline for returning finalized papers is April 2012.

Final papers will be published on flashcards.
